## How to access and use your court and its superior law.

1. What the removal of State case/claim does.
2. Instructions for printing/signing removal forms, and necessary attachment of State case/claim documents.
3. Mailing location for notary and clerk, for the Sovereign's use only!
4. The notary recording fee for titles and notarization, and why.

*Your sovereign court* has decided to utilize the court rules and procedures found within **Title 28 United States Code - Federal Civil Judicial Procedure and Rules**, to **implement and enforce the sovereign's inherent-law and court judgements!** We have taken this track, because those codes, rules and regulations were created by the Congress, and then **adopted** by them as **Positive-Law**, in order to comply with their **fundamental duty** [Article VI, US CONST] **to the member states to the Confederation.** The Congress has thus provided a mechanism whereby **we sovereign people upon the lands of the nation states** can implement and enforce the **provisions, terms and protections** found in The **Declaration of Independence** and The **Articles of Confederation treaty!**

### Removal of the State case or claim, and what it does:

1. You will find the court's "**removal**" form [generic "**allstates**" version] on the **district court to the federal circuit** web site <http://www.sovereigncourt.org> and also on the **county notary** Google Groups site <http://www.countynotary.org> **That form addresses every possible instance** of a foreign commercial entity or fiction gooberment agency's attack, on any national to the Confederation, by administrative process or corporate **BAR-Fly** U.S. or State Court process, whether civil or criminal! Do not increase the forms' four-page format, by adding your individual circumstances, arguments or other **irrelevant** particulars - **for any reason whatsoever!** Just **follow** the instructions, to the letter!

This court's "**removal**" form is not a suit for damages. It is **solely** intended to afford **you, the sovereign**, immediate relief, by **stopping** the BAR-Fly gooberment in its tracks! **That is what the removal does!** Additional proceedings, orders or judgements can be issued to recover seized or damaged property or assets. This will be further discussed with you by officers of your court, via future announcements.

**This court will enforce its judgements against any BAR-Fly venue or against any U.S., State, or local gooberment entity, but only** if you have fully followed the recording instructions given to you!

**Please** take note that **all** of our documents [including this instructional procedure] are **always** prepared, and **intended** to be printed and viewed, on 8-1/2" X 14" paper. The **fiction** BAR-Fly corporatism commercial-courts use 8-1/2" X 11" paper, **because** that is the **recognized commercial** format of **correspondence** In Their World System of fraud! Only 8-1/2" X 14" paper is referred to as **legal size** and for that **reason** is the lawful format in law!

## Instructions for removal forms:

2. Print out three complete [four-page] copies of the **removal form**, using a **color laser printer ONLY**, and **only on 8-1/2" X 14" paper**. **Sign only your given name**, and at only two places, on the forms. Do **not** fill out any other information, unless you want to be responsible for any mistakes that you may make which cause the forms to be **returned or rejected** by the **clerk!**

Sign your given name [ i.e. *David Clarence* ] on the bottom right of **page one of one page - notice of removal** under the letters **L.S.** and where the line ends with **suitor**. Also sign your given name at the bottom left side of **page two of three pages - removal suit** under the letters **L.S.** and where the line ends with **suitor**.

**Include** one **original**, or the original **copy**, of the document that was sent, mailed or served on you [the **clerk** requires the court name, parties, debtor and creditor, along with the court docket, case or collection, file or **claim** number identifying **exactly** how the **fiction** described the claim or case. That is all that you have to do to complete your **removal notice and suit!**

## The notary and clerk mailing location for the sovereign's use only:

3. The **senior notary** has leased a general post-office box location for the **sovereign** to transmit documents and correspondence. This location is **not** for the **fiction** or **BAR-Fly** to use! **You will transmit all documents via First-Class Mail, utilizing postage stamps and not postal meter-strips, as well as correspondence/ contributions to the following:**

## The notary recording fee for titles and notarization, and why:

### 4. Fee or contribution schedule -

One **silver dollar**, as an exchange of **intrinsic value**, for notary notarization. This applies to each **fiction case** that you the **sovereign** want to **remove to your sovereign court venue and jurisdiction**.

One **blank** [no recipient noted] United States Postal Money Order for each **fiction case** that you want to **remove to your sovereign court venue and jurisdiction**.

**Note:** this is a **suggested** contribution to cover the costs of color laser printing, copying and mailing by registered mail, all of the documents that must accompany **your removal notice** to all of the parties that must be notified. The suggested amount is **three-hundred fifty FRN's**.
